

# **BrevAll Technologies Managed Services Referral Program Terms and Conditions**

## **1. Program Overview**

The BrevAll Technologies Referral Program (“Program”) rewards individuals and organizations (“Referrers”) who introduce potential clients (“Referrals”) to our managed IT services. This Program applies to referrals involving businesses operating with **15 or more Users**.

## **2. Eligibility**

- Referrers must be at least 18 years of age and legally eligible to participate.
  - Referrals must be new to BrevAll Technologies and not previously engaged in any discussions or contracts with us.
  - The referred organization must sign a managed IT services agreement with BrevAll Technologies for the Referrer to qualify for full rewards.
  - Referrers must be current clients of BrevAll Technologies.

## **3. Referral Rewards Structure**

### **Part 1: Initial Referral Reward**

- Referrers will receive **\$300** or an alternative promotional offer at BrevAll’s discretion including but not limited to:
  - donation applied to their current bill
  - contribution to a charity of choice
  - donation to their nonprofit organization
- After a qualified referral results in a first meeting—regardless of whether the referral becomes a client.

### **Part 2: Conversion Bonus**

- If the referral signs a managed services agreement and pays their first invoice, the Referrer will receive an additional **\$700** or an alternative promotional offer at BrevAll’s discretion (as described above).

### Part 3: Referral Incentives for New Clients

- Referred clients may receive onboarding incentives, including:
    - Waived onboarding fees (up to **\$10,000**)
    - Other promotional offers at BrevAll's discretion
- 

### 4. Referral Process

- Referrers must facilitate a warm introduction including but not limited to:
    - Email introduction including all parties
    - In person introduction
    - Any type of call that includes all parties
  - that leads to a first meeting between BrevAll Technologies and the Referral.
  - BrevAll will confirm that the opportunity meets the minimum requirement of **15 Users**.
  - The initial reward will be issued after the first meeting and qualification confirmation.
  - The conversion bonus will be issued once the referred client pays their first invoice.

### 5. Special Case Scenarios

- For unique opportunities or high-value contracts, BrevAll may offer customized rewards (e.g., company lunches, personalized gifts).
  - These rewards will be determined on a case-by-case basis and communicated directly to the Referrer.

## **6. Limitations and Disqualifications**

- Self-referrals or referrals within the same organization are not eligible.
  - BrevAll reserves the right to disqualify any referral that does not meet the Program criteria or appears fraudulent.
  - Rewards are non-transferable and may be subject to applicable tax reporting.
