

FACILITATED EXERCISES— PREPARING FOR CRISIS

Testing an organization's plans through exercises is a practical, efficient, and cost-effective way for organizations to prepare for incident response and recovery. Exercises evaluate a company's ability to successfully execute one or more portions of its plan. Because the "fog of war" is typical in real-world crises, the best time to conduct an exercise is before an event happens. Pre-event testing allows those who are likely to be involved to familiarize themselves with the plan, practice the plan, and reinforce their roles and responsibilities.





- Ensure that the plan will stand up to a real crisis and identify any gaps in policies and procedures.
- Train the key persons who will be involved and responsible for planning and implementation.
- Strengthen the inter-departmental, inter-agency, and inter-sector links between the various organizations that may be involved.

The Compliance, Risk & Resilience team at B. Riley Advisory Services has been directly involved in preplanning and facilitating many types of emergency response, continuity events, and disaster recovery incident scenarios for exercises both in the U.S. and internationally. These have ranged from small tabletop exercises and plan "walk-throughs" to large, full-scale Homeland Security Exercise and Evaluation Program (HSEEP) exercises.

Exercises require careful preparation around clearly identified objectives. Once the objectives are identified, then designing, developing, conducting, and analyzing the results will allow those who are responsible for the plan to better understand its strengths and weaknesses in order to continually improve their resilience capabilities.

Effectively facilitating exercises is critical to keeping participants focused on exercise objectives. Our senior exercise facilitators delve into how the scenario decisions are made, how a decision is reached or what implications a decision might have for our client. The expected outcome of an exercise should be information that will indicate how to improve the plan. This information should capture the main points of the discussion and identify the gaps.
