INTRODUCTION & BACKGROUND

Empath Health

We were created in 2021 through the merger of two leading nonprofit, integrated networks of care: Empath Health, serving the Tampa Bay region and Stratum Health System, serving Southwest Florida and have continued to grow adding Hospice of Marion County in 2023 serving north central Florida and Trustbridge in 2024 in southeast Florida. The Empath Health integrated network of care provides expert medical, counseling and support services including hospice; home health; palliative care; grief services; all-inclusive elder care; HIV/STI prevention, services and support; primary care; and physician services. Empath Health is honored to have approximately 26,000 people enrolled in our Full Life Care services, creating a bridge between chronic, advanced, and terminal care and providing seamless integration based on individual needs. Our wide variety of community-based programs reflects our commitment to the preservation of our charitable mission.

With more than 60 years of skilled home health care expertise, Empath Home Health is a member of Empath Health's not-for-profit network of care. - Hospice Bereavement Counseling. Empath Health provides grief counseling and support services to all members/ages of the families of hospice patients for thirteen months after their loved one passes. Counseling services are offered at each of the three community services centers located in Pinellas County by licensed counselors and social workers and trained volunteers.
- Perinatal Loss Support. This specialized hospice program supports any families who are suffering from a pregnancy loss, still birth, or death of a baby shortly after birth. Services may begin when a diagnosis is made during pregnancy or delivery. Trained counselors provide individual and family counseling and support groups.
- Pediatric Program. Specialized pediatric hospice care teams are available to provide care for a seriously ill young child to help ease the child's suffering and give the best possible quality of life while supporting the entire family. The pediatric care teams are experts in caring for children of all ages (from infants to young adults) as they reach the final stages of an illness and life.

Veterans Programs. PURPOSE of this REQUEST FOR PROPOSAL

Empath Health is requesting proposals for:

Purpose and Objectives of this Request for Proposal

Empath-Stratum, Inc. requests proposals for Emergency Debris Collection, Hauling, and Removal Services in Response to Natural Disasters (hereinafter "Debris Removal Services") as outlined in this Request for Proposal (RFP). The package includes the requested scope of services, proposal forms, and requirements.

Empath-Stratum intends to retain one or more Contractors under a master services agreement (hereinafter referred to as the "Contract"). The term of the Contract will be three years (3 years), with provisions to extend if the requested scope of services cannot be completed within this time- period. No Contractor entering the Contract with Empath-Stratum, Inc. is assured of any minimum services requested or compensation provided; Empath-Stratum, Inc. retains the right to execute contracts with multiple contractors to perform the scope of services at its sole discretion.

All prospective Respondents will be afforded an opportunity to submit statements of qualifications in response to this request in receiving consideration for an award of any contract entered pursuant to this Request regardless of race, religion, color, national origin, age, sex, or disability.

This Request for Proposal (RFP) is an invitation by Empath Health for Respondents to submit an offer which will be subject to subsequent discussion. The submission of the proposal does not create any right in or expectation to a contract with Empath Health. Empath Health reserves the right to reject any or all proposals and the organization further declares that it will incur no financial obligations for any costs incurred by any company in preparing their proposal.

Submissions received after the deadline will not be considered. Quotations shall be binding and valid for a period of thirty days from the due date. Empath Health will award this procurement in total and will not accept partial quotations. The supplier will acknowledge the purchase order upon award, under the terms and conditions stated in the purchase contract.

- Empath Health reserves the right to increase or decrease the quantities specified.

The Purchasing Manager overseeing this RFP is Renee Perkie, Purchasing Manager for Empath Health and its affiliates. Please note that all Respondents to this RFP will be included in the responses to all questions submitted and the responses will be provided by e-mail at least once each week.

Empath Health may distribute supplemental instructions in the form of a written addenda. Any addenda will be provided to the Respondents contact of record (recipient of the e-mail invitation to participate in the RFP) via e-mail before the proposal due date. Empath Health is not responsible for any Respondent's failure to receive such addenda. Respondents are encouraged to contact Renee Perkie to ascertain whether any addenda have been issued. Failure to do so could result in a disqualified proposal. No oral explanation given to one respondent before the RFP opening shall be binding on other Respondents.

DUE DATES

Providers intending to respond to this RFP should submit their final proposals via e-mail by 8/28/2025 at 12pm. Proposals must contain all signed complete documents found within Section II: Attachments. Submissions received after the deadline will not be considered. Quotations shall be binding and valid for a period of sixty days from the due date. Empath Health will award this procurement in total and will not accept partial quotations. The supplier will acknowledge the purchase order upon award, under the terms and conditions stated in the purchase contract.

CONFIDENTIALITY STATEMENT

All materials and documents submitted by the provider in response to this RFP become the property of Empath Health and will not be returned. Any information considered to be the provider's trade secrets, privileged or confidential should not be revealed in the proposal. Provider responses are confidential and will be held in strict confidence, never shared with competing providers and only used by the decision-making team at Empath Health.

REQUESTED SCOPE OF SERVICE

The Contractor shall provide personnel, tools, equipment, transportation, supervision, and all other services required to ensure the timely and lawful disposal of storm-related debris, as directed by Empath-Stratum, Inc. and/or its contracted Emergency Debris Collection Monitor (hereinafter referred to as the "Monitor").

Under the direction of Empath-Stratum, Inc. and/or the Monitor, the Contractor shall collect and dispose of storm-related vegetative debris from locations needing debris removal based on a storm impact:

Processing and Collection of Debris

The Contractor shall, at the direction of Empath-Stratum, Inc., process and collect vegetative debris from the locations listed above. At certain locations, the Contractor may be required to process fallen trees and collect loose debris, stumps, and/or root balls. The Contractor shall be prepared to process leaning/fallen trees into manageable sizes for removal and disposal, extract or otherwise handle exposed stumps and associated root balls (including backfill of exposed root balls) and gather and consolidate loose vegetative debris scattered across the sites in identified areas to facilitate efficient loading and removal. Debris shall be loaded into trucks (must have solid tailgates) using machinery such as, but not limited to, truck-mounted grapples or front-end loaders with buckets and/or grapple attachments.

The Contractor must have the appropriate equipment and skilled personnel to safely and effectively carry out these tasks, ensuring compliance with all applicable local, state, and federal regulations.

Disposal of Debris

Vegetative debris collected by the Contractor from Empath-Stratum, Inc. locations shall be disposed of at an FDEP-permitted facility (permitted to receive vegetative debris). The Contractor shall, prior to commencing the requested scope of services, provide Empath-Stratum, Inc. with a list of disposal facilities (see Attachment C) that may be used to dispose of vegetative debris for each collection location specified in this scope of services.

Debris Disposal Documentation

Upon completion of loading vegetative debris into a truck at each Empath-Stratum, Inc. location, the Monitor's representative shall provide the truck's operator with load tickets. Upon arrival at the disposal facility, the truck's operator shall provide the Monitor with a copy of all load tickets associated with debris being disposed of per truckload; multiple load tickets will be provided in the event that a truck is transporting debris from multiple locations for disposal.

Debris Disposal Equipment and Personnel Certification

The Contractor shall comply with all certification requirements set forth by the Federal Emergency Management Agency (FEMA) to include:

- Equipment possessing valid registrations, insurance, and safety requirements as required by local, State, and Federal regulations.
- Operators possessing valid licenses, endorsements, and/or certifications.
- Making all trucks available for dimension/capacity measurement (measurements conducted/reported by Empath-Stratum, Inc. and/or Monitor).

Contract Selection Criteria

Empath Stratum will select a proposal based upon Scoring Matrix Criteria. Empath Health may conduct interviews with prospective bidders to determine execution timelines if not expressly provided in a contractor's bidding documents.
