

Glass Breakage

Lifetime Limited Warranty 1600 Series Windows

Glass Breakage:

MI Windows and Doors, LLC (MIWD), the manufacturer of Series 1600 windows, warrants that, should the glass break or crack in your Series 1600 window system, for as long as you the Original Purchaser / Property Owner shall live and own the property at the address listed herein, shall provide a sealed glass unit at no charge except for shipping and handling charges. Installation is not covered and is the responsibility of the homeowner. Replacement parts may not be an exact aesthetic match to the original.

Exclusions:

Removal of the windows from the premises invalidates the Warranty. Acts of God (floods, earthquakes, fires and acts of civil unrest, wars, riots, etc.) are excluded from coverage. Only single-family residential units are covered herein. Architectural (bent glass) bay *I* bow windows, patio doors and beveled or grooved glass are excluded. Windows that exceed Series 1600 size limitations are excluded. Apartment buildings, condominiums, and commercial buildings are also excluded from coverage.

The provisions of the warranty are the full and complete warranty policy extended by MIWD.

THE WARRANTY STATEMENTS CONTAINED IN THIS LIMITED WARRANTY SET FORTH THE ONLY EXPRESS WARRANTIES EXTENDED BY MIWD FOR THE GLASS AND THE PROVISIONS HEREOF SHALL NOT BE LIABLE TO THE PROPERTY OWNER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND FOR THE BREACH OF ANY EXPRESS OR IMPLIED WARRANTY ON THE GLASS.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights and you may also have other rights, which vary from state to state.

Claims Procedure:

Any obligation of MIWD is contingent upon proper notice by individual owner covered by the glass breakage warranty and an opportunity for MIWD to perform. Please submit your warranty claim in writing to MI Windows and Doors, LLC, P.O. Box 370, Gratz Pennsylvania 17030, Attention: Consumer Services. The claim must include proof of ownership, a copy of your original contract, proof of purchase and must contain the factory order number and window order number from the window warranty label. This label is found on the underside of the window mainframe just above the top sash. MIWD reserves the right to inspect the premises if required. A reasonable time shall be allowed for such an inspection.

The replacement glass will be shipped to the nearest designated distributor. Shipping and handling charges shall be paid by the homeowner and pick-up of the unit must be arranged by the homeowner at the location.
