MEDICAL MARIJUANA IS LEGAL

What is medical marijuana?

Medical marijuana uses the cannabis plant or chemicals in it to treat diseases or conditions. For more information about the state's medical marijuana use law, look up Section 381.986, Florida Statutes (F.S).

Is medical marijuana legal in Florida?

Yes. The Compassionate Medical Cannabis Act of 2014 in Florida statute allows a qualified patient to use medical marijuana and low-THC cannabis.

What are the qualifying conditions to use medical marijuana in Florida?

- Cancer
- Epilepsy
- Glaucoma
- HIV/AIDS
- Post-traumatic stress disorder (PTSD)
- Amyotrophic lateral sclerosis (ALS)
- Crohn's disease
- Parkinson's disease
- Multiple sclerosis (MS)
- Medical conditions of the same kind or class as or comparable to the others listed
- A terminal condition diagnosed by a physician
- Chronic nonmalignant pain caused by a qualifying medical condition

What steps should I take to get medical marijuana in Florida?

- STEP 1.** Be a permanent or seasonal resident of Florida
- STEP 2.** Be diagnosed with a qualifying medical condition by a qualified physician
- STEP 3.** Be entered into the state's Medical Marijuana Use Registry
- STEP 4.** Obtain a Medical Marijuana Use Registry (MMUR) identification Card to make purchases at a Licensed Medical Marijuana Treatment Center (MMTC)

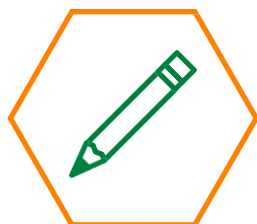
