

Tax Time Thinking

Are you getting a refund? Think about any changes you may want to make to the amount of tax deductions that come out of your paycheck. Do you want to decrease the amount so that you have more throughout the year to pay down debt or save in an interest bearing account? Many people prefer getting a large refund. They feel it is the only way they can save, or they do not want to risk having to make a lump sum payment if taxes are owed. Consider putting a set amount out of each paycheck into a special savings account, but you will have to be disciplined not to touch it if you want to have it all this time next year.

Think about direct deposit, but don't spend money paying for an advance of your refund from tax preparers or loan companies. Why pay them to get your money just a few weeks earlier? Direct Deposit is faster and safer than paper checks. Make sure you have correct account information; names on your tax refund should match the names on your account that you are depositing into.

If you don't have an **emergency fund**, begin one with this year's refund. This way you can avoid debt when something unexpected comes up. Actually you should expect the unexpected to happen. Everyone is likely to have some type of emergency related to cars, major appliances, your house, and unplanned medical needs. Begin an emergency fund and add money to it from each paycheck.

Consider paying off debt. Make a list of all the debt you owe sorted by balance size with the largest balance at the top and the smallest balance at the bottom. Work to pay off the smallest balance first. Then keep working up the list, using any available money.

Would you want to purchase **Savings Bonds** with your refund? This year the government is letting you receive all or part of your refund in Series I US Savings Bonds. The amount has to be in multiples of \$50, and you can receive direct deposit for any difference over the amount of Bonds you are purchasing. Check out www.irs.gov for more details.

Making the Right Money Moves

(Rome Ga.) --- As part of our financial literacy effort for young people, Coosa Valley Credit Union is making a program aptly named, MAKING THE RIGHT MONEY MOVES, available to area high schools. As of today, Coosa Valley has provided basic financial skills to 1,345 young adults that attend 7 area high schools!

Students learn to make wise financial decisions with this program using a student workbook, role-play simulations, CD and video exercises. Practical lessons on the importance of saving, as well as keeping a checking account in balance and reconciling it with a bank statement are all part of this program. In learn-by-doing exercises, young adults teach themselves the value of good credit, how to determine their own capacity to borrow and repay, and what they can do as young adults to build a good credit history. They also learn how to avoid identity theft.

Coosa Valley is sponsoring MAKING THE RIGHT MONEY MOVES as a public service. "We feel it is important that young adults have a chance to practice money management in the classroom, where mistakes won't cost real dollars," stated Ron Tomlinson, President/CEO of Coosa Valley Credit Union.
