FHC OPENS NEW TRAINING CENTER

The Family Health Centers, Inc. opens its new state-of-the-art training center. The training center is located next to Family Health Center's main site, 1445 Presidential Drive Street, Orangeburg, SC 29115, which will offer opportunities for employee training and staff development.

The 12,184 square foot facility will include a 250-seat multipurpose room that can be divided into four training rooms and will also house FHC staff, which include the finance, accounting, billing, purchasing, scheduling department, mammogram, X-Ray rooms, ultrasound, telemedicine, rural residency planning and development program, conference room, and staff lounge.

The facility will be used for new employee training and for annual refresher training for the existing workforce to keep them up to date with technological advances. The total investment for the new training facility is estimated at more than \$1 million.

X-rays are a form of electromagnetic radiation, like visible light. Unlike light, however, x-rays have higher energy and can pass through most objects, including the body. Medical x-rays are used to generate images of bone, tissues, and structures inside your body.

Family Health Centers, Inc. Hold Giveaway

Inflation is reaching levels not seen in 40 years, making it difficult for many to supply their daily needs.

The Family Health Centers, Inc. in Orangeburg took a little bite out of the high grocery costs by providing families with healthy food during a giveaway event.

"It is tremendously meaningful for us to be a part of this," FHC CEO Leon Brunson Sr. said.

Brunson described the food giveaways as "very positive" and something FHC is grateful to be a part of.

"We have 600 people every time we open up every Friday, basically," he said.

600 boxes of produce and nonperishable goods were given out from FHC's main site parking lot, located at 3310 Magnolia Street.

FHC has provided free food boxes to over 1,400 families in Orangeburg and Calhoun counties since the program started in January 2022.

The food giveaway is done at least twice a month, both at the Orangeburg and St. Matthews Family Health Center offices.

The food giveaway has been made possible through a \$130,000 South Carolina Department of Commerce grant for Orangeburg and Calhoun counties.

The grant was given to Harvest Hope Food Bank for its Mobile Food Pantry program.

Harvest Hope is South Carolina's largest food bank, providing over 20 million meals on average across the Midlands, Pee Dee and Upstate.

The grant will fund food giveaways on a monthly basis for the next year, Harvest Hope Food Bank Director of Development and Agency Relations Chad Scott said.

Scott said Orangeburg and Calhoun counties were selected for the food program grant due to the high rate of diabetes in the community.

"The boxes we handed out are food and produce geared toward those with that condition," Scott said. "As we evolved, we realized and identified specific health needs in specific communities where we can better allocate resources to provide the best quality foods that meet that specific need."

FHC Farmers Market Manager Katana Jones said, "Feeding the community is

everything. "Caring is definitely sharing. Groceries are high. Gas is high. Helping anybody at this point in time is a blessing."

FHC Outreach employee Davarsha O'Neal said the food giveaway is crucial during these times. "Grocery prices are going up," O'Neal said. "It is an opportunity to help the community with getting, not all the groceries, but some of the groceries they need to relieve them of their hardship at the moment." He said, "It feels good that I can actually help people."

Free food box recipients must meet the Commodity Supplemental Food Program income guidelines.


The Commodity Supplemental Food Program works to improve the health of low-income families by supplementing their diets with nutritious USDA foods. The CSFP program is administered through the Food and Nutrition Service of the USDA.

Hypertension Management Program

The Family Health Centers, Inc. has initiated a Hypertension Management Program. The Management program will offer:

- Hypertension Evaluation by a provider for 30 minutes with possible follow up. The provider will discuss methods to manage and treat high blood pressure along with medications if needed.
- Free Electronic Blood Pressure Monitors
- Free Android Phone which will send home blood pressure readings to your chart at Family Health Centers for evaluation by your primary care provider.

The Hypertension Management Program can help you manage, treat, and reduce your high blood pressure. Adult patients aged 18 or older who have a diagnosis of hypertension are eligible for the program. New patients are welcome.

Diabetes Management Program

Are you a diabetic or pre diabetic patient of the Family Health Centers, Inc.? Family Health Centers, Inc has a fresh produce program for all diabetic and pre diabetic patients. We have partnered with Food Share of South Carolina to provide qualified patients with free fresh food boxes filled with healthy fruits and vegetables.

All diabetic and pre diabetic patients must be referred to the VeggieRX program by medical staff. Once the referral is made, they will be contacted by the VeggieRX Coordinator with information on how to receive their box. Once the referral is processed, their box will be available for pick up twice a month from one of Family Health Centers' seven locations. After three months, all patients must visit with their medical provider for updated A1c levels for a new referral to receive a fresh produce box for an additional three months.

Diabetic patients will receive the following free gifts:

- Smart Phone w/paid service for one year
- Glucometer (Bluetooth enabled)
- BP monitor (Bluetooth enabled)
- Pulse Ox (Bluetooth enabled)

To be qualify for the free gifts, you must be established with a FHC provider and have a diagnosis of diabetes. Walk-in only patients do not qualify.

FAMILY HEALTH CENTERS, INC. OFFERING COVID-19 TESTING AND VACCINES





The Family Health Centers, Inc. rolled out a vaccination and testing program in January 2022 to combat ongoing variants of COVID 19. In doing so, FHC administrated record numbers OF COVID 19 Testing and Vaccines in all their service locations in Orangeburg, Bamberg, Calhoun, and Upper Dorchester counties.

Since 2020, the world has experienced these new variants of COVID-19. As a result, we have witnessed insurmountable amounts of fear, uncertainty, and death. As the country approaches its third year of adapting to the changes brought on by the coronavirus pandemic, we saw firsthand how the shutdowns and restrictions have impacted everyday life.

From remote work and school schedules to new ways to attend events and

church services, COVID-19 continues to alter how we live. After more than three years of adjusting to strict guidelines, many Americans got vaccines and started to resume a more normal life. But many more remain at risk until they get vaccinated, and experts are still tracking the emergence of virus variants that could pose new threats.

The Family Health Centers, Inc. administered a record number of Pfizer-BioNTech and Moderna to men, women, and children to reduce a person's risk of contracting the virus that causes COVID-19. Vaccines are highly effective against severe illness. FHC has administered the following doses from January 1, 2020 through March 15, 2022: Moderna Vaccine 1 – (15,052); Moderna Vaccine 2 – (14,870); and Moderna Booster – (5,286); Pfizer – (57).

FAMILY HEALTH CENTERS, INC. Receives \$200,000 Grant for Covid Vaccine Outreach Efforts



The Family Health Centers, Inc. recently was awarded \$200,000 from the South Carolina Department of Health and Environmental Control (DHEC) to promote health equity in Covid-19 vaccinations. The award is expected to last for six months and can be renewed up to three times for a total period of two years. FHC will use the funds to serve as trusted messengers within their communities to help reduce barriers to vaccine access among disadvantaged or underserved populations. "The

federal funding will support to ensure individuals in rural areas and minority or vulnerable communities obtain the information they need to make informed decisions about vaccines from people they know and trust," said FHC Leon A. Brunson, Chief Executive Officer.

The outreach initiatives will be centered on increasing community-level engagement about the safety, effectiveness, and benefits of COVID-19 vaccines and why they are essential to ending the pandemic. The purpose of the COVID-19 Vaccine Outreach Initiative is to increase awareness and knowledge of COVID-19 and COVID-19 vaccines, and/or reduce vaccine hesitancy or barriers, in a manner that results in increased vaccinations among members of key populations, such as: 1. those living in rural areas (areas that lack access to broadband, healthcare, and other services), 2. minority residents (African American, Latinx, Native American, Asian American and Pacific Islander, etc.), 3. and other vulnerable communities.

FAMILY HEALTH CENTERS, INC. OFFERING PAXLOVID COVID-19 TREATMENT





The Family Health Centers, Inc. is now offering Paxlovid COVID-19 treatment to qualifying individuals. The Paxlovid will be offered Monday through Friday from 8:00 a.m. to 5:00 p.m. at all Family Health Centers located in Orangeburg, Holly Hill, Vance, Denmark, Neeses, St. George, and St. Matthews.

Paxlovid is indicated for the treatment of mild-moderate COVID-19 in adults and children (12 years of age and older weighing at least 40 kg) with a positive COVID-19

test who are at high risk for progressing to severe COVID-19, including hospitalization or death. People must have symptoms of COVID-19 and those symptoms must have started within the last five days.

Paxlovid is an oral antiviral pill that can be taken at home to help keep high-risk patients from getting so sick that they need to be hospitalized.

100% of Family Health Centers, Inc. Employees Are Vaccinated Against COVID-19

FAMILY HEALTH CENTERS, INC. RECEIVES \$750,000 FROM HRSA TO DEVELOP RURAL RESIDENCY PROGRAM

The Family Health Centers, Inc. has received a \$750,000 in federal grant funds from the Health Resources and Services Administration (HRSA) to develop a new Rural Residency Program. HRSA awarded approximately \$20 million in Rural Residency Planning and Development (RRPD) grants to recipients across 21 states. The awards will support recipients' efforts to develop new rural residency programs while achieving Accreditation Council for Graduate Medical Education (ACGME) accreditation."This grant award will provide us with the opportunity to explore how we can better train and attract more family medicine providers to serve patients in our rural communities," said Leon A. Brunson, Sr., Chief Executive officer, Family Health Centers, Inc. "Research determines that providers who train in rural communities are most likely to stay in those communities to practice medicine. "Also, this grant funding will assist us in enhancing the pool of long-term practicing providers."

The Rural Residency Planning and Development Program grant will be utilized as start-up funding for a family medicine residency program at the Family Health Centers, Inc. The program will be a collaboration between Family Health Centers, Inc. (FHC), Orangeburg, SC; The Regional Medical Center (TRMC), Orangeburg, SC; and Edward Via College of Osteopathic Medicine (VCOM) in Spartanburg, SC. FHC, TRMC, and VCOM have come together to form a Graduate Medical Education Consortium to develop a rural Residency Program in Family Medicine that addresses the primary care workforce shortage and encourages providers to remain in the area to practice upon completion of their Graduate Medical Education. The Rural Residency Planning and Development program grant will allow the members of the consortium to plan and develop the necessary resident and faculty training curricula and recruitment strategies needed to conduct a high quality and sustainable Rural Residency program. The goal of the program is to train communitybased practicing primary care physicians to become leaders in health care transformation and enhance teaching in community-based settings. The program is training primary care preceptors who will be prepared to supervise residents.

The goals of the project are achieved accreditation for the program through ACGME; ensure sustainability of the program through public or private funding beyond the period of performance;



and track resident's career outcomes post-graduation, including but not limited to retention in rural communities for at least five years after the first graduating class. The consortium will seek to matriculate the first class by July 1, 2023, but no later than the required date of Fall 2024.

The anticipated long-term goals of the program are:

- Training and retention of an increased number of physicians in rural, underserved areas, specifically within the healthcare service region of consortium partners; leading to:
- Improved access to health care for those in rural, underserved areas,
- Improved quality of care for those in rural, underserved areas, and
- Decreased cost of care for those in rural, underserved areas.

FHC is also preparing to enhance continuing medical education and Graduate Medical Education through the construction of a Training Center and Telemedicine Hub (over 12000 total square feet) adjacent to the main health center site in Orangeburg. The training center will include space for live training and will be equipped to provide training in telemedicine outreach as well as distance learning to support the educational needs of the residents. The new Training Center will expand the existing capacity of FHC for telemedicine outreach. FHC has received Distance Learning and Telemedicine funding to purchase the equipment for the Training Center from the USDA Rural Development office. The construction of the Training Center is scheduled for completion by Dec. 30, 2022.

VCOM goals of the programs are:

 Recruiting students from and educating students in the socioeconomically depressed regions of Virginia, North Carolina, South Carolina, Louisiana, and Alabama, especially those in rural Appalachia, the Delta region, and the tobacco and cotton regions of the Southern States.

- Recruiting students with a strong desire to care for medically underserved populations.
- Fostering a desire and commitment in medical students to an enhanced understanding of global healthcare and disaster medicine.
- Fostering primary care, and healthcare for medically underserved populations.
- Promoting primary care practices and osteopathic distinctiveness.
- Developing a diverse workforce of physicians who will practice in underserved areas.
- Providing outreach to rural communities and the uninsured.
- Promoting mission medicine.

TRMC is a VCOM-affiliated clinical rotation partner and has successfully met all requirements in partnership with VCOM to provide a model medical curriculum and training to VCOM's third and fourth-year medical students since 2013. Clinical rotations are designed to provide a rigorous and broad foundation for primary care medicine, including hands-on experiences in rural and medically underserved areas, through which students gain an appreciation for the many rewards of rural and community-based medicine. TRMC also operates outreach clinics in areas not currently served by FHC and plans to incorporate these clinics in the rural residency program.

FHC and TRMC both serve the rural and medically underserved area that encompasses Orangeburg, Bamberg, and Calhoun Counties in South Carolina. Orangeburg and Bamberg Counties are designated wholly rural by Federal Office of Rural Health Policy (FORHP) while half of Calhoun County has a rural designation. The entire area has HRSA Medically Underserved Area (MUA) and Health Provider Shortage Area (HPSA) designations. The shortage of access to primary care is reflected in significant health disparities, especially among the low income and minority populations of the area.

The geographic area in which the proposed residency program will be located includes Orangeburg, Bamberg, Calhoun, and Dorchester Counties. The town of Orangeburg where FHC has its main site, and where TRMC is located, will be the base of the residency program.

Each month, the Family Health Centers, Inc. features a National Health Observances that align with our mission to improve health across the United States. Health Awareness months aim to raise awareness about certain health conditions and topics.

February is American Heart Month, and the goal of Family Health Centers, Inc. is to show support and raise awareness for heart disease, which is the leading cause of death in the United States.

In celebration of American Heart Month, FHC staff celebrated "National Wear Red Day to help build awareness of heart disease in both men and women. FHC staff wore red designer t-shirts in support of the day. The Chief Executive Officer, Leon A. Brunson, Sr., provided the red designer t-shirts to all staff members.

A pop-up banner and pamphlets were placed at each FHC satellite location highlighting American Heart Month.

In addition, the Family Health Centers, Inc. had a live zoom presentation on February 24th entitled "Pay Attention to Hypertension," presented by Mrs. Julia Hobson, Family Nurse Practitioner, at the Community Medical Center in Vance, SC.

According to the Centers for Disease Control and Prevention, heart disease is the leading cause of death in the United States and is a major cause of disability. The most common heart disease in the United States is coronary heart disease, which often appears as a heart attack.

Heart disease is the leading cause of death for men and women in the United States. Every year, 1 in 4 deaths are caused by heart disease.

The good news: Heart disease can often be prevented when people make healthy choices and manage their health conditions. Communities, health professionals, and families can work together to create opportunities for people to make healthier choices.

During the month of March, the Family Health Centers, Inc. celebrated Colorectal Cancer Month. A popup banner and pamphlets were placed at each FHC satellite location highlighting Colorectal Cancer Awareness Month.

Colorectal cancer, or CRC, is a disease of the colon or rectum, which are parts of the digestive system. Unlike most cancers, colorectal cancer is often preventable with screening and highly treatable when detected early.

Most cases of colorectal cancer occur in people ages 45 and older, but the disease is increasingly affecting younger people. Each year, about 150,000 Americans are diagnosed with this disease and more than 50,000 die.

Colorectal cancer may develop without symptoms.

With screening, colorectal cancer is one of the most preventable cancers. Colon cancer and rectal cancer are also highly treatable if caught early. That's why on-time screening is essential and lifesaving. Screening should begin at age 45.

In addition, FHC Presents Colorectal Cancer Screening Forum was held on March 24, 2022, with a zoom live presentation by Dr. Loren Harter, family medicine physician at Community Medical Center in Vance, SC. Dr. Harter discussed cancer facts, warning signs, and treatment options.

SELENA LOWERY NAMED APPOINTED DIRECTOR OF HIV SERVICES



Mrs. Selena Lowery currently serves as the Director of HIV Services at Family Health Centers, Inc. Previously, she worked for The Wright Wellness Center (formerly South Carolina HIV Council) as the Lead Medical Case Manager. Mrs. Lowery has devoted the past 12 years in HIV Prevention and Care at both the community and state level.

According to Mrs. Lowery, this nation is on its third update to the National HIV/AIDS Strategy, yet most people who are not directly impacted by the strategy, have never heard of it. There is a national problem that elicited a response from the White House and most people have never heard of it. The first National HIV/AIDS Strategy was released in 2010 under the Obama Administration with three goals. The first goal was to reduce the number of new infections. The second goal was to increase access to care and health outcomes for People Living with HIV. The third goal was to reduce health disparities.


The National HIV/AIDS Strategy (NHAS) was later revised in 2015 and most recently, in 2021. In 2015, another goal was added to the plan to improve the coordination of programs in HIV. The 2021 version of NHAS sets forth bold targets for ending the HIV epidemic by 2030. The federal government required each authority or state to adopt its own plan to meet these targets. The plan for South Carolina is called *Ending the Epidemics*.

While the goals have been outlined by the plan, you may wonder how will the Family Health Centers, Inc. (FHC) fall in line to realistically reduce the number of people affected by HIV, increase access to care and health outcomes for People Living with HIV, reduce health disparities, and improve program coordination? The answer begins with the conversation. The conversation should begin with the patient's first medical visit and should be ongoing.

FHC is normalizing conversations around HIV and prevention and have routinized HIV testing and are empowering our clients with HIV prevention tools such as preexposure prophylaxis (PrEP). Our HIV care system is working hard to keep our clients virally suppressed and engaged in their care. We have representation in the community to help combat stigma and bridge the gap for underrepresented people and communities. We are forming relationships with other organizations and ensuring that we have meaningful inclusion from People Living with HIV in our conversations.

As we enter the 42nd year of HIV in the US, we must come together to have the conversation about Ending the HIV Epidemic. It is the responsibility of everyone at FHC. We recognize that there is much work that needs to be done to end the HIV epidemic. Therefore, we must keep the conversations going.
