### Agreement Terms and Conditions

Contract must be accompanied by a 10% deposit to secure your date and time. An additional 60% is due before August 31st. The final 30% and any additional fees must be received NO later than 2 weeks before the scheduled event. If the balance is not paid in full by the deadline, the event and time will be released. The Texas Renaissance Festival will then be relieved of all responsibility to provide facilities and or services. We reserve the right to refuse service to anyone.

**Cancellation/refunds:** If a written notice of cancellation is received 30 days or more before the planned event, half of the monies paid in excess of the non-refundable deposit will be refunded. No refunds will be made for events cancelled less than 30 days before the date of the scheduled event. There are NO refunds or rescheduling will be done due to inclement weather unless the Park has to be closed due to weather conditions. Your wedding time and location may be subject to change in special weather circumstances.

We accept personal checks, cash, or any major credit card for payment. Checks will not be accepted for deposit or payments if your event is closer than 2 weeks before your event.

If available, overtime use of the reception venues may be arranged at \$500.00 per hour payable at the time of the request.

**No outside food or beverages are permitted in the Park.** This includes wedding cake. Any food or beverages provided for guests over the amount paid prior to the event day will be charged to your account immediately following the event.

You may select the photographer or videographer of your choice. Commercial photography, video, and filming activities are conducted at the Texas Renaissance Festival. You may appear in resulting pictures or film that may be used in advertising, press releases, entertainment, or other activities. Entry into the Park and/or the purchase of a ticket constitutes consent for the Texas Renaissance Festival to use the resulting pictures, videos, and films without compensation to you.

The state of Texas requires a Marriage License to make the Wedding legal. You may obtain a license from your local county clerk's office in the state of Texas. In Texas, a Marriage License must be issued at least 72 hours before the ceremony can be performed, and no later than 90 days after the issuance. **A Marriage License issued in the state of Texas is good in any county in Texas.** Your marriage license should be given to the wedding staff the day of your wedding. We are required to sign this and mail it to the county where it was purchased. If you live in another state, you must obtain your license in the state of Texas.  
**PLEASE CHECK YOUR STATE/COUNTY FOR REQUIREMENTS.**

The couple agrees to comply with all laws of the USA, the State of Texas, the City of Todd Mission, and Grimes County. The couple further agrees to assume all liability for all damages, theft, and/or loss to the Texas Renaissance Festival. In addition, the couple, will defend, indemnify, and hold harmless Texas Renaissance Festival, its owner, officers, employees, agents, and shareholders from any and all liability or damages, including reasonable attorneys' fees resulting from claims, demands, costs, or judgments arising from or out of any occurrence in, upon, or at the premises, regardless of who asserts such claim.

This Contract contains the entire agreement between the parties relating to the use of the premises and there are no prior representations, warranties, or understandings, verbal, or otherwise, between the parties except set out in this Contract. This Contract may be amended only in writing by the Texas Renaissance Festival.
